Please do not break down booths until the fair ends. Remove valuables overnight. Fairview Lake is not responsible for lost, stolen, or damaged items at any time.

The fair will be held indoors. Each space is approx. 10x10 ft. Vendors must use assigned spaces, bring their own tables, and display products safely. Chairs are available. Vendors are responsible for their own sales, taxes, and permits. Vendors selling food must comply with all state and county regulations, and obtain all insurance, permits and certifications. Unauthorized sales of food or beverage is prohibited. WiFi is available. Electricity is limited. Youth vendors are welcome and will have a dedicated space.

This is a family-friendly event. The sale of weapons, alcohol, tobacco, or marijuana products is prohibited. Re-selling mass-produced items or commercial direct-sales brands (MLMs) is strictly prohibited. Art and goods must be produced through physical or traditional digital craftsmanship, not via text-prompt algorithms or generative software. The Y reserves the right to remove inappropriate items or eject anyone whose conduct is not in the best interest of camp without refund.
